Jerome Gunderson seconded. Motion passed unanimously.

<u>VSO Spring School April 17 – 19 2018 (Continuing Education):</u> Kurt Jackson and Keith Thorpe will be attending Spring School 2018.

<u>Grant:</u> Kurt Jackson reported that after the expenses of National Training and VSO Spring School, there will be approximately \$2,000.00 grant money remaining to be allocated before 30 June 2018.
