DISCUSSION ITEMS:

A staff report was presented by Read.

APPROVAL OF HIRE AND PAY FOR TRISTAN HUNT- ACTION 24-59. Van Zante reported that 38 applications were received for the position at Mariposa. Van Zante, Kramer, Stone, Ratliff and VanderPol conducted interviews with the top 4 applicants. Tristan Hunt was selected for the position. Tristan worked

with Jasper County Conservation for the last 2 summers and his work was top notch. He will graduate from Central College on May 10 and will start May 13. Board members discussed pay and suggested a start at Step 3 of the Maintenace 2 pay scale, \$23.35/hour. Motion by Friedman, second by Yeager to approve the hire of Tristan Hunt at Step 3, \$23.35 for Maintenance Tech 2 at Mariposa Park. Motion carried unanimously.

APPROVAL OF BIDS FOR ROCK ENGRAVING AT MARIPOSA CAMPGROUND- ACTION 24-60. Two bids were received to engrave the rock at the entrance of Mariposa Campground. T&J Flooring bid \$2500 and Mingo Products bid \$850. Motion by Friedman, second by Yeager to accept the low bid of \$850 from Mingo Products. Motion carried unanimously.

NORTH SKUNK WILDLIFE AREA- ACTION 24-61. Van Zante reported that she has been receiving complaints regarding hunting access at the landlocked North Skunk River Wildlife Area. People would like to hunt the area but surrounding landowners will not give access. Board members discussed how it is not the intention of the board to have inaccessible hunting areas, but that those areas should be managed as wildlife habitat. Motion by Friedman, second by Yeager to change the North Skunk Willde area to a no hunting wildlife preserve. Motion carried unanimously.

Mariposa Campground and Cabin- Cabinet and countertops are finished in the cabin. Still need to do flooring, decks, shower house partitions and a bit more seeding before the June 1, 2024 opening date.

Nature Center. Plans for the nature center have been completed and Greiner is now working on bid packages to be let so prices and budget can be determined.

Other. Nothing identified.

Board Member Concerns. None identified.
