## **DISCUSSION ITEMS:**

Staff reports were presented by Cantu, Oldsen, Ratliff, and Read.

**ASHTON PARK PLAN- ACTION 25-36.** Board members traveled to Ashton Park as a part of a special meeting on November 19, 2024. The board looked at the house and walked the parcel so that discussions about its future could be held. The house needs much updating, including flooring, bathrooms, kitchen, basement leaks, and a major electrical update. Members discussed the cost to update the house compared to the benefit, as no officer will be living in the park now. Motion by Yeager, second by Friedman that the house at Ashton Park be torn down. Motion carried unanimously.

**NATURE CENTER DONOR WALL- ACTION 25-37.** Staff have worked with local artist Karen King to develop a concept of a live edge epoxy stream donor wall. The original art piece will be 4' x 8' and will be engraved with all of the donors over \$1,000. King has priced the art at \$4,200 but will donate half, so cost to JCCB would be \$2,100. Motion by Friedman, second by Yeager to utilize Karen King for the donor wall at the cost of \$2,100. Motion carried unanimously.

**My County Parks "Nearby Attractions".** Read presented an opportunity to include 6 nearby attractions on the Jasper County page of the my county parks website. Board and staff discussed whether this would be a paid advertising or if we offer it for free. Staff also talked about ways to make it fair for all interested to have a chance to fill one of the 6 spots. Stone asked staff to come up with a proposal and bring it back to the January meeting for a decision.
