### CENTRAL IOWA HOUSING TRUST FUND GRANT AGREEMENT

**RECIPIENT:** Jasper County **PROJECT NAME:** Jasper County General Assistance

This Central Iowa Housing Trust Fund Contract (<u>"Contract"</u>) is effective as of January 27, 2025 (the <u>"Effective Date"</u>) by and between the Central Iowa Housing Trust Fund (together with its successors, the <u>"TRUST FUND"</u>) and Jasper County, Iowa, an eligible applicant, (the "<u>RECIPIENT"</u>).

WHEREAS, the RECIPIENT is certified as such by the Trust Fund based upon qualifications specified in the most recently approved RECIPIENT Application, as applicable;

WHEREAS, the RECIPIENT has been awarded CIHTF funds for an eligible RECIPIENT project in which the RECIPIENT will act as the developer, owner, or sponsor;

WHEREAS, the RECIPIENT is eligible for a Grant under the CIHTF Program;

WHEREAS, the Trust Fund has approved a Grant to the RECIPIENT for rental assistance for eligible households in the amount of **\$12,780.00** (the <u>"CIHTF Grant"</u>), and the RECIPIENT has agreed to accept the CIHTF Grant subject to the terms and conditions set forth herein;

WHEREAS, the CIHTF Grant amount is the combined amounts of **\$10,000.00 in CIHTF funds** and **\$2,780.00 of local funds** utilized as local match;

WHEREAS, the RECIPIENT has agreed that 100% of the funds will be used to benefit households at or below 80% Area Median Income (AMI) and **approximately \$9,000.00 will be used to benefit households with incomes at or below 30% AMI**;

NOW, THEREFORE, in consideration of the mutual covenants and conditions set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

<u>Section 1.</u> **CIHTF Grant:** Subject to the terms and conditions contained in this Contract, including Exhibit A, the Trust Fund agrees to disburse the CIHTF Grant to help finance the reasonable and necessary costs for the approved project. CIHTF funds for eligible RECIPIENT activities are reserved for Eligible Costs incurred during the period commencing on the Effective Date. Such disbursements shall not, in the aggregate, exceed that amount designated as the CIHTF Grant in this Contract, and all disbursements shall be made in accordance with the certification made in Exhibit B and the procedures set forth in the Trust Fund's CIHTF Program Rules and Regulations. In no instance shall the Trust Fund be liable for any costs incurred in excess of the CIHTF Grant, nor for any unauthorized or ineligible costs.

<u>Section 2.</u> Eligible Costs: The CIHTF Grant will be expended only for reasonable and necessary costs for the project as outlined in the RECIPIENT's application (Exhibit C) and generally defined as follows: The project funds will be utilized to provide emergency rental assistance to eligible households in Jasper County.

<u>Section 3.</u> **Disbursement of Funds:** The CIHTF Grant will be disbursed by the Trust Fund via check upon submission of an executed copy of Exhibit B to this Contract, verified invoices, and household information. The proposed use of the funds must be certified in the Exhibit B and limited to Eligible Costs. All disbursements must be expended for Eligible Costs within 15 days after receipt by the RECIPIENT or returned to the Trust Fund.

<u>Section 4.</u> **Compliance with Program Requirements:** During the performance of this Contract, the RECIPIENT shall comply with any and all applicable legal requirements, including, but not limited to, the following:

(i) The National Affordable Housing Act of 1990; and Department of Housing and Urban Development regulations at 24 CFR 92.

(ii) Title VI of the Civil Rights Act of 1964 as amended (Public Law 88-352; 42 U.S.C. 2000d et seq.); Title VIII of the Civil Rights Act of 1968 as amended (Public Law 90-284; 42 U.S.C. 3601 et seq.); the Iowa Civil Rights Act of 1965; Iowa Code section 19B.7, and Executive Order #34, dated July 22, 1988; Iowa Code Chapter 216; Presidential Executive Order 11063, as amended by Executive Order 12259; Presidential Executive Order 11246, as amended; Section 504 of the Rehabilitation Act of 1973 as amended (29 U.S.C. 794); the Americans with Disabilities Act, as applicable, (P. L. 101-336, 42 U.S.C. 12101-12213; the Age Discrimination Act of 1975 as amended (42 U.S.C. 6101 et seq.); and related Civil Rights and Equal Opportunity statutes; and regulations which implement these laws.

(iii) Fair Housing Act, Public Law 90-284. The Fair Housing Act is part of Title VIII of the Civil Rights Act of 1968 as amended (42 U.S.C. 3601 et seq.) and regulations such as Section 92.351 of the Final Rule which implement these laws.

(iv) Executive Orders 11625, 12432, and 12138 as amended and Section 92.351 of the Final Rule, to encourage the use of minority and women's business enterprises in connection with activities funded under the program.

(v) Fair Labor Standards Act and implementing regulations.

(vi) Government-wide Restriction on Lobbying Certification [Section 319 of Public Law 101-121] and implementing regulations such as 24 CFR 91.225, 24 CFR 91.235, and 24 CFR 91.425.

(vii) Hatch Act (regarding political partisan activity and federally funded activities) and implementing regulations.

<u>Section 5.</u> **Right to Inspect Records:** The RECIPIENT shall permit the Trust Fund, its agents and designees reasonable access to its books and records, including all financial statements and records. The RECIPIENT further agrees to furnish such other information to the Trust Fund, as and

when requested, for the purpose of determining the RECIPIENT's compliance with this Contract and the CIHTF Program Rules and Regulations.

<u>Section 6.</u> **Record Retention:** All records pertaining to this Agreement shall be retained for a period of five (5) years beginning with the date upon which the final disbursement under this Agreement is made.

<u>Section 7.</u> Non-Discrimination: The RECIPIENT shall ensure that no person shall on the grounds of race, color, religion, creed, sex, sexual orientation, gender identity, national origin, age, disability, or familial status be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity funded in whole or in part with funds provided under this Contract.

<u>Section 8.</u> Term of the Contract: This Contract shall be in full force and effect from the Effective Date and shall continue in effect until **12/31/2025**, unless extended by mutual agreement of the parties.





#### 8. Project Overview

General Assistance provides temporary assistance to low income residents of Jasper County when such persons are not supported by their own means or other public or private resources, and in accordance with Chapter 252 of the Code of Iowa and the Jasper County General Assistance Resolution. An application process is utilized to determine eligibility. Applicants must be a resident of Jasper County, 18 years of age or older, and meet income and resource guidelines. Federal poverty guidelines are utilized in determining income eligibility for households at or below 200% of poverty. All others may be considered on a case by case basis.

#### 9. Experience

The General Assistance program was established many years ago. The current Director has been administering the program for over 15 years. We have been fortunate to have received a CIHTF grant for the past 4 years.

#### 10. Objectives

The current program sets rental assistance for needy applicants in an amount up to \$500.00, one time only, in emergency situations when an eviction notice or notice of nonpayment has been received. Deposits or first month's rent are not covered, but are frequently requested. Additionally, inflation and the current economic environment have contributed to an increased past due amount for many renters. We hope to utilize the additional grant funds to expand assistance and fill this need by waiving the late payment requirement to allow for help with deposits or first month's rent, and to increase the maximum amount of assistance to aid individuals in obtaining and maintaining affordable housing and prevent homelessness.

#### 11. Timeline

Funds will be distributed on a monthly basis until the entire grant amount is utilized, or the grant deadline for expenditures has been reached, whichever comes first.

#### 12. For Proposed Rental Projects

Number of families served and individual assistance amounts will be determined by our application process. Applicants currently served span the Area Median Income limits of 30% AMI, 50% AMI, and 80% AMI. The majority and target group fall under the 30% threshold.

#### 13. For Proposed Homeownership Projects

Not applicable. We assist with rent only. No mortgage payments are made.

#### 14. Proposed Financing

Not applicable.

#### 15. Qualification Process

The General Assistance Program requires that our Application be completed and income verification documents submitted to determine eligibility. Backup documents include photo ID, bank statements for any bank accounts, wage stubs for the household, and award letter from social security as applicable. Other documentation may be requested such as SNAP and FIP benefits, child support, unemployment, etc., as determined by the information shown on the application. We also require that the landlord complete a form to verify occupancy and rent amounts. Copies of the General Assistance Application and Landlord Questionnaire Form are attached.



# Memorandum of Understanding

The Jasper County Board of Supervisors, based on the request of Michael Frietsch, County Engineer have approved the recommended restructuring of the workforce within the Secondary Roads' Department. As part of the restructuring, the addition of five (5) hourly Crew Leaders will be added to replace the current contractual positions of the three (3) Working Foreman.

This decision has been attained due to the need and efficiency of the workforce. The Engineer reserves the right to adjust, modify, or eliminate the established staffing, work duties, or the supplemental pay associated with the position of Crew Leader.

As part of this MOU, both parties; Jasper County (employer) and Public, Professional, and Maintenance Employees, (union) agree to the following:

- 1. The creation of five (5) hourly positions of Crew Leader
- 2. These positions will be posted to fill the vacancy, with management selecting the most qualified individual. Seniority will be looked at, but will not be the deciding factor in the decision
- 3. Newly assigned Crew Leaders will be placed in a one (1) year probationary period
- 4. During the probationary period, newly assigned Crew Leaders will be provided a six (6) month and one (1) year performance evaluation to discuss performance and establishing goals
- 5. Upon assignment of a Crew Leader position, the employee will receive supplemental pay of one dollar (\$1.00) per hour during the probationary period for additional responsibilities
- 6. Upon completion of the probationary period, Crew Leaders will receive an additional supplemental pay of fifty cents (\$0.50) per hour making the total supplemental pay \$1.50 per hour after one year.
- 7. Grade III Skilled Laborer vacant positions will be posted in the future by "Primary Duties" to allow employees to move to different positions (Motorgrader, Truck Driver, Bridge Crew, etc.)
