



- Capstone Behavioral Health can screen
  - o refers to places such as <u>Clearview</u>, <u>Sheepgate</u>, or other places with openings.
- Anyone can refer to Capstone for substance or mental health screening.
  - o If issues, call Julie Smith.
  - o If a referral to inpatient is needed after screening
  - o Options in Jasper County: Clearview Recovery (women) and Sheepgate (men).
  - Other substance inpatient. See resource guide for options.
  - o Note: Manning is often used for substance/mental health with a hospital.
