# MY BODY MY RULES

Personal Safety Information for Kids

## **MY BODY BELONGS TO ME!**

- I can say "No" to anyone who wants to hug or kiss me when I don't want to.
- These are things I can do instead fist bump, high five or a handshake.
- It's MY body and I'm the boss of it!

## **MY SAFE AND TRUSTED ADULTS**

- I have **5 safe adults** I can tell anything to.
- If I feel frightened, uncomfortable or nervous about something, I can tell one of these 5 adults.
- If one of my safe adults doesn't listen or believe me, I need to **keep telling** other safe adults.

## **WARNING SIGNS**

- If I begin to feel scared or unsafe, my body may begin to sweat or I might get a funny feeling in my tummy. My heart might start to beat really fast too. These are warning signs that might mean something is wrong.
- If I get these kinds of feelings, it's important I tell one of my 5 grown ups right away.

## **PRIVATE PARTS**

- My private parts are the parts of my body that my swimming suit covers up.
- I call my private parts by their correct names not nicknames.
- No one can touch me in my private parts and no one can ask me to touch someone else's private parts.
- No one should ever show me pictures of someone's private parts either.
- If something like this happens, I need to tell one of my trusted adults right away.



## **UNSAFE SECRETS**

- Unsafe secrets are secrets that make me feel scared or uncomfortable. If someone asks me to keep something a secret that makes me feel frightened, I need to tell a trusted adult right away.
- Kisses and touches are things that should never be kept a secret.

## 2025 Iowa Youth Survey Talking Points

## **July 2025**

These talking points may be used to guide conversations with school officials and other interested parties about the Iowa Youth Survey (IYS).

IYS information, including questionnaire content, can be found on the <u>lowa Youth</u> <u>Survey webpage</u>.

## What is the Iowa Youth Survey and what information is collected?

- The IYS is a survey that collects data on issues facing lowa students.
- The IYS includes questions about actions and beliefs about healthy eating, physical activity, community involvement, substance use, gambling, school engagement, bullying, mental health, screen time, and safety.
- No student is required to answer any question he or she is uncomfortable answering, and students can stop completing the survey at any time
- o Results are confidential and individuals are not identifiable.

## Why does participation matter?

- A high rate of participation benefits the individual school, county and state by providing more representative data.
  - Student success is affected by all aspects of the environment. Schools cannot control the outside environment, but knowing what factors are present can help inform programs, policies, and processes to give students their best chance at success.
- In 2021, approximately 91% of school districts participated in the Iowa Youth Survey, with data from nearly 50,000 students collected. In 2023, 2% of school districts and approximately 2,200 students participated. We need schools and students to participate in order to understand the current needs of youth in Iowa.



## How can I encourage participation in my community?

- Visit with Superintendents, Principals, counselors, nurses, and/or lead health education teachers about the importance of participating in the 2025 lowa Youth Survey.
- Encourage parents to provide active permission for their student(s) to take part in this survey. Students may not take the survey without their parent or guardian's consent. This is an important step in keeping parents informed and making sure they have the right to decide what their students are involved in!

## Tips for talking with school officials about participation in the IYS

- Consider showing exactly how you and other community partners use IYS data to support the school district and youth in your service area. Here are some examples that may be of interest to communities.
  - Educational programming for mental health or substance use.
  - Highlight the need for resources such as a community garden to improve access to fruits and vegetables or a community food pantry to address food insecurity.
  - Develop awareness campaigns aimed at reducing bullying among youth.
  - Understand youth substance use behaviors for parental and community education.
  - Partnering with local schools and parks and recreation organizations to improve physical activity opportunities for youth.
- If your district has not participated in recent years, share what data you would like to use in your community that could be collected through IYS participation.
