PRIMARY ELECTION**

WHEREAS, the PRIMARY ELECTION was held as prescribed by law on June 2, 2026, and:

WHEREAS, the Board of Supervisors and *ex-officio* Board of Canvassers has canvassed the vote of said elections in accordance with §50.24 of the *Code of Iowa*, now therefore;

BE IT HEREBY RESOLVED that we, the undersigned members of the Board of Supervisors and *ex-officio* Board of Canvassers of Jasper County, Iowa, do hereby certify the following TURNOUT REPORT and RESULTS in the PRIMARY ELECTION, held June 2, 2026, and that no obvious clerical errors were identified during the canvass.

Four thousand two hundred and sixty-eight (**4,268**) people voted at the polls on election day.

Eight hundred forty-four (**844**) absentee ballots were accepted for counting.

Zero (**0**) provisional ballots were accepted for counting (subset of absentee ballots).

A total of five thousand one hundred and twelve (**5,112**) people voted.
